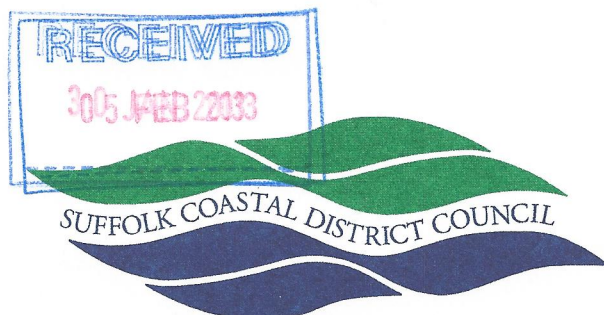

Suffolk Coastal District Council received on 25 January 2013 a Tree Works Notice relating to the above trees.

The Local Planning Authority has six weeks from the date the Notice was received to consider whether it is expedient in the general interests of public amenity to make a Tree Preservation Order in respect of the tree(s). If by 08 March 2013, the instigator of the proposal does not hear from the Local Planning Authority, they may carry out the work in accordance with the Notice as long as the work is carried out within two years from the date of the Notice. It is however, policy to endeavour to inform them of the outcome before the six week target date.

The Local Authority Arboricultural Officer will visit the property to make a visual assessment of the proposed works on the character of the conservation area.

If you wish to submit comments on the proposal, please do so by 22 February 2013. Any comments made will be available for viewing by the public during normal office hours Monday to Thursday 09:00 to 17:00 and Fridays 09:00 to 16:30.
