10.124.01 SNT Report

A copy of the report from the Woodbridge SNT tabled was received and noted.

In response to a question at the previous months meeting PCSO Smith had sent an email advising that the travellers staying at Sutton Heath are on private land and have been given permission to stay indefinitely. The other two smaller sites are also privately owned and the travellers have been told by the owner to vacate the land in six months time.

- 10.124.02 Community Fun Day**
Council was advised of the community fun day being held in aid of 'Help for Heroes' in the Hall Farm Estate on 31st July 2010.
- 10.124.03 Posters and Notices at Melton Cross Roads**
It was reported that again there was a proliferation of signs at the crossroads and it was agreed to monitor the situation and report any persistent misuse to SCDC
- 10.124.04 Horse and Groom**
Concern was expressed about the future of the Horse and Groom and it was agreed that the Clerk should contact SCDC to ascertain if they are aware of any pre-application discussions that they were able to share with MPC.
- 10.124.05 BMX Trail**
The meeting was advised that Just42 Ltd were currently sourcing the management group and setting up a properly constituted group to run the trail. This would enable proper insurance to be obtained and funding from grant makers applied for. SCDC had advised that planning consent would be required so Just42 would prepare the application although it would need to be submitted in the name of Melton Parish Council
- 10.124.06 Girdlestone – Judicial Review**
The meeting was advised that until formal planning consent was granted it was not technically possible to instigate a judicial review as there was nothing to review currently.

Concern was expressed by the meeting about the use of consultants by SCC when central government was encouraging restraint in expenditure of this kind.

- 10.126.01 Beresford Drive/Bredfield Road**
Cllr Bond advised that he had raised the issue of the state of the land at the corner of Beresford Drive and the parking of builders' vehicles opposite the building site on Bredfield Road but as yet had not received a reply.
- 10.126.02 St Audry's House Nuisance**
He had also followed up the matter of the noise nuisance at St Audry's House as this was once more becoming an increasing problem and was awaiting a reply.

Cllr Bond confirmed that he had written to the Head of Legal Services requesting that the S106 agreement be thoroughly investigated to see if Hopkins Homes were acting within the legal constraints of the agreement.
