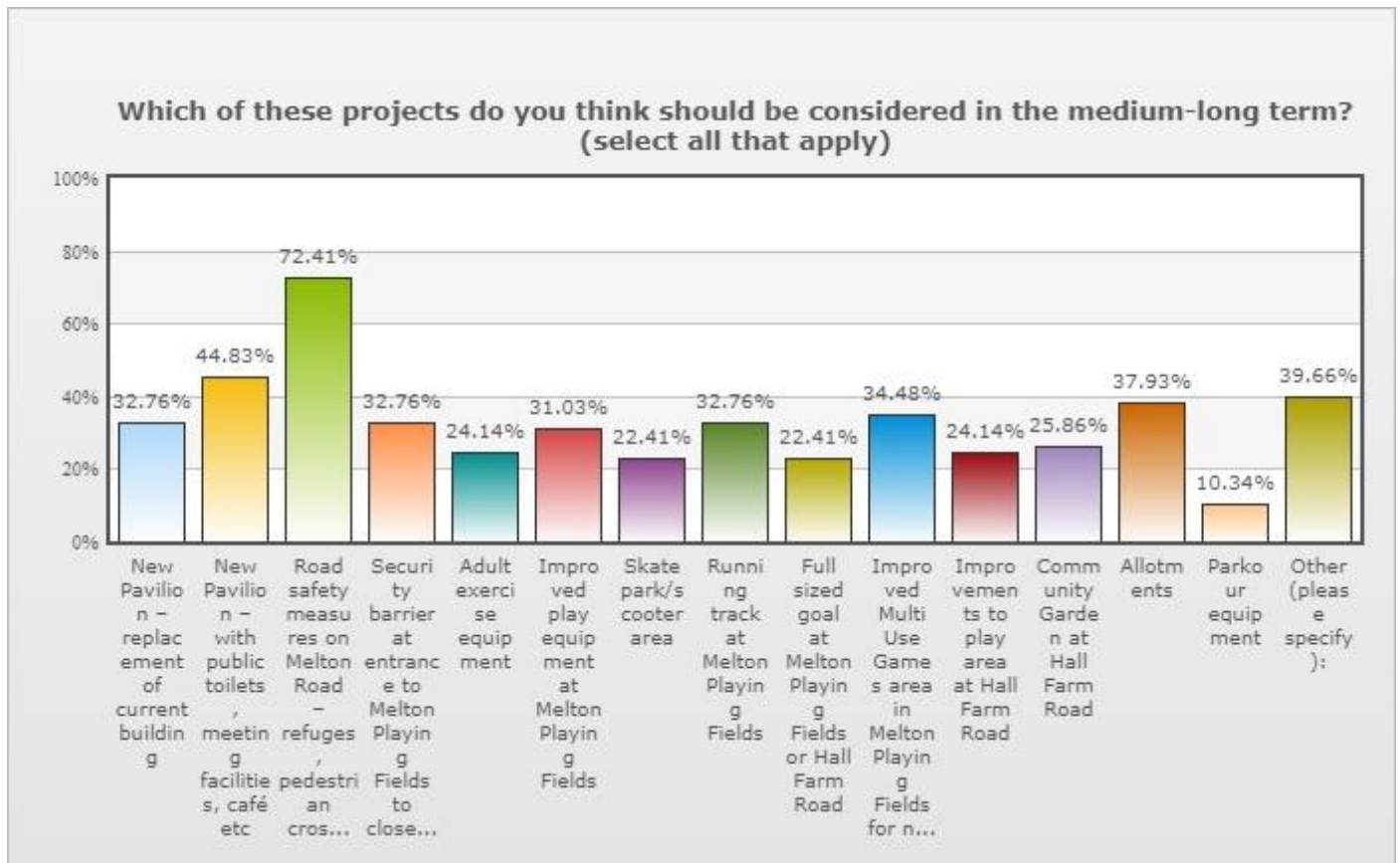

Community Infrastructure Levy (CIL) and Grant Funded Projects

The NP/CIL project open events took place in early February and a resident survey has been running since then. There have been 58 responses collected to date. The responses are in line with the feedback gathered at the open events. Responses are being collated but early results show support for the following projects:

1. Road Safety measures
2. New Pavilion (preference is for public toilets)
3. Allotments
4. Running track
5. Improved MUGA

Full results from the survey are shown below:



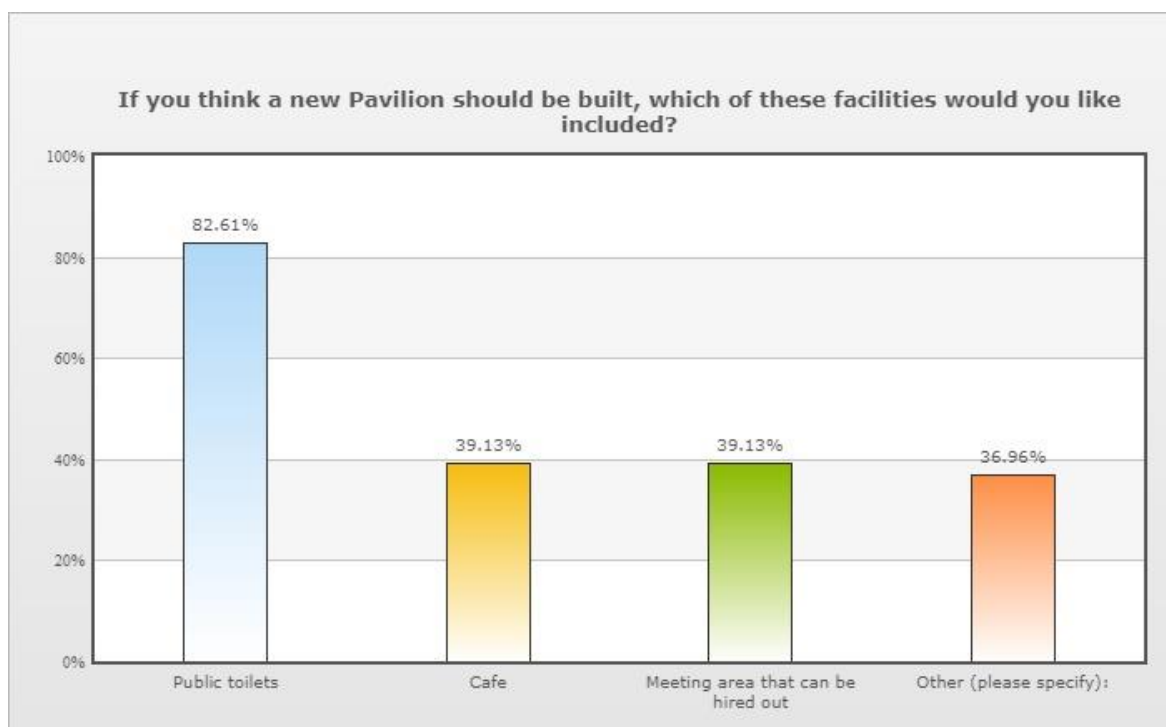
The 'other' comments are listed below but there is a trend for a shelter for people watching sporting events/supervising the play area and supporting St Audry's cricket/social club:

- Sheltered area by design for spectators of sporting events and for persons using the play area.
- Shelter from the elements for users and spectators on the field.
- Shelter for parents and spectators from wind and rain (Pagoda/Pergola type)
- Outside covered space with seating
- Village Hall

- Two meeting areas
- Village Hall
- Plug in facility for pop up cafe
- Yes, to toilets at the pavilion, but no to meeting room and cafe. Do not over-complicate the building on the playing field. It's not the location for a meeting room. Encourage small local businesses to hook-up and provide food and drink, eg coffee cart, street food, etc, etc
- I think if there is a new pavilion it should be a modest, green development that doesn't destroy green space
- Hopscotch area
- Public toilets would be a useful amenity but would need to be maintained and regularly monitored and this should be factored into any plans for future development/investment
- Why do we need to hire out a meeting room when we have Riduna Park generating income, St. Andrews church hall, St Audry's club, Burness rooms and as yet possibly facilities on The Development opposite the playing field and the former council offices site.
- Melton Road is becoming a major route and anything that encourages etc extra movements onto this road should be discouraged.
- The on-going financial implications of a meeting area would be excessively costly and the desirability of such a space is not proven.

Feedback gathered at the open events relating to other projects that should be considered:

- Bus shelters
- Sun or rain shelters at park
- Best use of funds would be to support acquisition of St Audry's Social club and land (x 5)
- Rickshaw tuk/tuk travel
- Move Melton Village sign further up Woods Lane so that the new development feels part of the village.
- Benches.
- Crossings. Cycle Paths. Cycle parks.
- More quality benches (perhaps memorial) positioned in small groups around the playing field. Current provision is inadequate.
- A professionally produced guide to walks in Melton and the immediate area (x 3)
- More 'About Melton' boards like the one located on Melton station platform. One on the playing fields would be good.
- A 'quiet place' on Melton playing fields with plants and benches etc. would need properly maintain but would be of value and could be planned / maintained with commercial partners. (x2) – similar to the 'quiet space' at the back of Notcutts.



The results will be discussed at Full Council on the 18th March and decisions taken on what projects should be progressed.
