At the meeting of Planning and Transport Committee held on 4 November it was resolved to maintain the Council's objection to the revised application and continue to recommend refusal, as it was felt that the fundamental problems with the proposal still remain. East Suffolk Council Planning Committee (South) considered the application on 30 March when it was REFUSED. Clerk to update.
